RELEASE OF LIABILITY – 2 Month Display **Cycle 2022**

Your artwork is being submitted to the EGFAC for display for a two month **show cycle**. Each cycle will start on the first Saturday of each month and end on the second to last Thursday of the second month. See schedule below. Artwork must remain on display until the end of the two- month cycle.

- **2D AND 3D Fees will be determined by the exterior/base size of each piece per month (Including 2D frame or 3D base/footprint. 3D footprint may include a grouping of smaller pieces):**
 - 9 x 12 or smaller: \$10.00 per month
 - Between 9.5 x 12.5 up through 16 x 20: \$15.00 per month
 - Between 16.5 x 20.5 up through 24 x 36: \$20.00 per month
 - Larger than 24 x 36: \$25.00 per month
- **JEWELRY and FABRIC ART – Fees will be \$2 per piece per month.**
- **Each** piece of Jewelry **must** be delivered already tagged with artist name, item number and price, matching your inventory list attached.
- **Upon delivery of works** please bring your piece(s) of art to the Elk Grove Fine Arts Center along with payment and this completed Release of Liability form. **Payment for both months is required at the time of submission.**
- All submissions will be juried for acceptance at time of delivery. Wall art of any medium must be gallery ready: framed or matted and wired for hanging. **Write an inventory list on the back of this form if needed** (or attach) with the Title, Medium, and Selling Price for each numbered piece being entered. Label artwork with artist name and item number to match the inventory list.
- EGFAC will take responsibility for collecting and paying any sales tax.
- EGFAC will **10%** charge Commissions on sales. If your piece is sold during the month, a check will be mailed to you within the first 2 weeks of the month following the sale of the art work.

I hereby release the Elk Grove Fine Arts Center and its representatives from liability for loss of, damage to, or maintenance of the artwork listed **on back of this form** (or attached) while on display at 9683 Elk Grove-Florin Road., Elk Grove, CA 95624.
