ENTRY FEE

Each artist may submit up to 5 pieces for one entry fee of \$35.00. Only three pieces from each artist may be accepted for inclusion in the show.

CONDITIONS OF ENTRY:

- All artwork must be original fine art quality conceived and created solely by the entering artist(s). Submit only original work that has been finished in the last 2 years. Original work means no class or workshop art, no copies, giclees or enhanced giclees or works by any commercial printing process (except for photography), no copyrighted works.
- All artwork must be appropriate for family viewing and may not have been previously accepted into any EGFAC competition. All art must be for sale.
- **THIS SHOW HAS SIZE LIMITS:** All mediums appropriate for the exhibition are accepted and must be ready to hang or display. Hanging artwork must be no larger than 11"x14" for this show and weigh less than 40 lbs.
- Sculptures over 50 lbs must be set up by the artist. Installations must meet OSHA, fire and safety codes and free-standing work must be stable and safe for viewing.
- All canvas works must have finished painted edges and any works less than ¾ gallery wrapped must be framed. All hanging pieces must be wired using only D-rings and the wire ends must be taped. No protruding nails, staples or sawtooth hanger may be used. Works with glass must have rigid frames.
- Be sure the following information is placed on the back of 2-D works and the bottoms or backs of 3-D works: Name, address, title of the piece, size of the piece, media and price
- EGFAC handles all sales from the exhibition and retains a 40% commission from all sales.
- All artwork remains on-display through the exhibition dates unless otherwise noted.
- Artists must provide the Gallery Price for their artwork in whole dollar amounts. ***There are no price adjustments permitted after art intake.***

ARTIST PAYMENTS: Payment of the net sale proceeds (sale price, less commission) will be processed via check at the end of the exhibition. Check will be mailed to the Artist address on file.

The submission of art to the exhibition shall imply an agreement on the part of the artist to the conditions set forth in the prospectus and the Elk Grove Fine Arts Center Works on Consignment Agreement. The Artist consents to the use of his/her name and artwork image(s) for purposes of promotion and advertisement by the Elk Grove Fine Arts Center. Accepted artists will be required to sign the Works on Consignment Agreement for Art Competitions.
